# Front Cover Booking pre-emption policy

- A. Normal Pre-emption-Front cover booking is subject to pre-emption by higher booking volume with maximum of 6 full pages booking within P1 to P9 including Mega front cover and back cover. Mega front cover plus 1 full page booking before P9 pre-empts Front Cover Booking. Mega front cover plus 2 full pages booking before P9 pre-empts the previous one. Pre-emption is determined by higher booking volume when 'new comer' buys up to 5 full pages within P1 to P9 (including Mega front cover) which is more than 'previous booked client'. Mega front cover with back cover pre-empts Mega front cover with P3. Loading charge is imposed on these pre-empted bookings except front cover.
- B. Special Consecutive Package

i. When 'new comer' pre-empts Front Cover Booking by buying maximum of 6 full pages within P1 to P9 including Mega front cover and back cover, at least 30% loading charge will be imposed on all bookings except front cover. A higher loading percentage pre-empts lower one. Pre-emption will be determined by higher loading charge in such case. All confirmed bookings arose from such front cover pre-emption is non-cancellable and non-refundable;

ii. 'Previous front cover booked client' reserves the priority of Front Cover Booking if it fulfills clause (B)(i). Pre-emption single Mega front cover can pre-empt box ad on front cover plus P3:
